Chair's Statement

Ms. Clare McGrath



On the 8th of December, I was delighted and very proud to accept my appointment as Chair of Water Safety Ireland. When making this announcement, the Minister for Rural and Community Development, Heather Humphreys TD, paid particular tribute to our organisation's rich history of volunteerism and the deep commitment shown by volunteers who teach swimming and lifesaving and promote drowning prevention initiatives nationwide.

We can certainly be proud of the fact that we are consistently to the fore in raising awareness of the dangers of drowning and this is so well reflected in communities nationwide in which our members educate and train thousands of people in water safety best practices.

My objective is to continue our efforts to bring drownings down further by promoting the necessary rescue skills, attitudes and behaviours. I very much look forward to working with the WSI Council and engaging its Commissions, our thirty Water Safety Area Committees nationwide and the members, Local Authorities, and other Agencies to develop policies and projects that help encourage more participation and engagement at all levels.

Over the next five years as Chairperson I look forward to providing leadership to the Council in the continued delivery of Ireland's National Drowning Prevention Strategy 2018-2027, and the strategic development of the organisation. Overall drowning rates have continued to decrease over the decades and in addition to your efforts in this regard, I thank the outgoing Chair Martin O'Sullivan for his commitment to the many tasks at hand and the WSI staff for the support they give to drowning prevention.

The last two years have been especially demanding due to the challenges of COVID-19, which affected our teaching, training of Lifeguards, summer weeks, lifesaving sport and all our other activities. I would again like to thank our outgoing Chair leading the organisation in a very professional manner during these challenging times.

Despite the Covid-19 pandemic, we still managed to do quite a number of our activities, albeit at reduced capacity in some cases. The Sports Commission managed a national outdoor competition – our National Lifesaving Championships - at the beginning of October in Kilkee, Co. Clare. Our Water Safety Area Committees managed to run summer weeks following a new standard operating procedure and while numbers were curtailed, thankfully some venues were able to operate. We made changes to our Lifeguard training regime to ensure that beaches, pools and waterways had trained qualified Lifeguards on duty. Our winter courses also proceeded following Government guidelines and a specific standard operating procedure agreed by our Technical Committee. From this perspective I especially wish to highlight the excellent work of our Winter and Summer Course Organisers, especially during 2021 within Covid restrictions.

The number of lives saved and aquatic accidents avoided as a result of the work carried out by all of our active volunteers can never be fully enumerated, although one figure that brings home the importance of this work is the number of rescues performed by Lifeguards each year, a figure which reached 473 during 2021. These same Lifeguards, trained and assessed by Water Safety Ireland, administered first aid on over 6,000 occasions and reunited with their loved ones, more than 500 children found wandering alone by the water's edge.



I want to take this opportunity to express my sincere gratitude to each of the Committees, Commissions and Working Groups, who have remained focused throughout the year.

While Covid-19 continues to present challenges, the Inshore Rescue Boats Commission provided safety cover for our surf championships and organised two I.R.B courses throughout the year. WSI's Lifeguard Commission modified the Lifesaving and Lifeguard Syllabi for use during the Covid-19 period, and tailored the Local Authority Beach Lifeguard Tests for nationwide use in both pool and open water settings.

Risk Assessments were a priority activity for the Rescue Commission in 2021, particularly on Blue Flag Beaches, as well as reviewing the VAT inspection process in line with recent SAR developments.

I would like to recognise the Education Committee and Strategic Marketing Committee for targeting at-risk groups with initiatives to highlight best practice so that drownings are reduced. These initiatives and public awareness campaigns endeavour to keep water safety in the public consciousness all year round. Through continued government funding and sponsorship, we were able to reinforce our 'Better Safe Than Sorry' brand message across audio, print and digital promotions. One such initiative this year is our "Hold Hands" programme for Early Learning Centres which empowers creches to start teaching water safety at a very early age.

An important and indeed historic day for the drowning prevention community in Ireland during 2021 was the approval by the United Nations of the first ever resolution on drowning prevention which will be marked annually on the 25th of July. We are grateful to the many Lifeguards, parents and children, heritage sites and the range of buildings and organisations that in some way went blue to mark the occasion.

I wish to thank each member of the Council for their commitment and dedication to ensuring that 2021 projects were successfully completed. I look forward with confidence to the continued growth of our organisation and a future free of Covid-19 related hinderances.

The staff of Water Safety Ireland's Head Office provide essential support all year round. Without them we could not deliver on our objectives. I would like to thank them for their continued hard work and especially in adapting to the new arrangements resulting from Covid-19.

Water Safety Area Committees

The organisation has thirty Water Safety Area Committees, arranged almost on a county basis plus the Defence Forces and the Gárda Síochána Water Safety Area Committees. Much recognition must be afforded to these Water Safety Area Committees who devise a programme of events and courses to cover their areas for the year. In addition to delivering water safety promotional programmes and demonstrations at schools, colleges, businesses, exhibitions and community events, each Committee delivers an extensive programme of pool water safety sessions in the winter and beach, lake and river water safety sessions in the summer.

The official membership structure is of a voluntary nature with over five thousand members nationwide. It operates on a number of different levels: Life Governors, Examiners, Trainee Examiners, Tutors, Instructors, Trainee Instructors and Non-Technical Volunteer Organisers. Each Local Authority has a Water Safety Development Officer who is a member of Water Safety Ireland.

Thanks to all their efforts to promote water safety we have seen a significant increase in the development of water safety awareness in local communities.

The SEIKO “Just In Time” Award

Over twenty lives were saved from drowning through the brave actions of rescuers who received recognition at Water Safety Ireland’s online National Awards Ceremony on Tuesday 30th of November 2021. For the second consecutive year, the Award Ceremony was an online only event due to Covid-19 restriction and was broadcast on Water Safety Ireland’s website and social media channels. WSI is grateful to Timemark for sponsoring the Seiko watches. Details of each rescue are listed in this report. Long-Service Volunteer Awards were also presented to 23 volunteers, recognising a combined total of 500 years of service teaching swimming, water rescue and survival skills in communities nationwide.

Certification

There are two broad categories of certification – Swimming and Lifesaving. Certification reflects the efforts of our voluntary members who change skills, attitudes and behaviours by instilling water confidence and deep-water swimming and survival ability.

Water Safety Area Committees processed 10,135 Swimming, Lifesaving and Water Safety certificates in 2021. In addition, a further 21,671 Primary School Aquatics Water Safety (PAWS) certificates were processed, 10,325 of the Seal, Marlin and Orca certificates were issued giving a total certification by Water Safety Ireland of 42,131.

Primary Aquatics Water Safety (PAWS) is Water Safety Ireland’s program of certification for primary school children and a component of the physical education strand of the primary school curriculum, A total of 21,671 PAWS Certificates were issued in 2021.

Summer Water Safety Weeks

WSI Water Safety Area Committees nationwide run an extensive series of swimming and water safety weeks throughout the summer in pools, rivers, lakes and beachfronts. Many of these classes extend beyond the summer in places that have pools and leisure centres.

Swim weeks consist of instruction in swimming and water safety weeks develop skills in rescue, water survival and basic life support.

Classes made a return in 2021 after a break of one year and adhered to a new Covid-19 standard operating procedure to ensure the safety of volunteers and participants.

Hold Hands

A new ‘Hold Hands’ pre-primary school water safety education programme was developed in partnership with the Department of Children and Youth Affairs. It was launched in 2021 to over 4,000 Early Learning and Care Centres nationwide by Ministers Heather Humphreys and Roderic O’Gorman. The programme was established alongside WSI’s early learning water safety advocate, Amanda Cambridge whose three-year-old son, Avery Greene, tragically drowned in a swimming pool accident in 2019.

The programme contains six storyboards which highlight potential water safety dangers at home, on farms, at the beach, at rivers, lakes and on holidays. These resources aim to grab children’s imagination and reinforce the core message that young children should always hold an adult’s hand near water. Included with the storyboards was a hand shaped pointing device which a child can hold, to instil behavioural changes taught in the programme.

World Drowning Prevention Resolution

The United Nations General Assembly approved the first ever resolution on Drowning Prevention in 2021. The resolution was an initiative of both Ireland and Bangladesh who along with co-sponsoring member states can be proud of this historic UN effort to save lives. This was an important and memorable day for the drowning prevention community worldwide.

A key element of the resolution is a UN designated world drowning prevention day, to be observed annually on the 25th July. Activities took place around the world to mark the day, using #DrowningPrevention.

As part of the initiative, Water Safety Ireland asked people to ‘Go Blue for World Drowning Prevention Day’ by illuminating their organisations’ building in the colour blue, lighting up a window in their home, by wearing blue face paint or clothing. A dedicated section on

watersafety.ie showcased the efforts of WSI members and the public online.

Twenty-four lives were saved from drowning by rescuers who received recognition at Water Safety Ireland's National Annual Awards Ceremony, broadcasted online at 7pm on Tuesday 30th November 2021.

The Minister for Rural and Community Development Heather Humphreys TD acknowledged recipients of a range of Awards including the SEIKO Just in Time Awards, Long Service Awards, and Recognition Awards for services rendered to Water Safety Ireland and also the Volunteer of the Year Award. Among the recipients are members of the public, members of Water Safety Ireland and other individuals and organisations who assist in the reduction of drownings by supporting the work of Water Safety Ireland throughout the year.

Long-Service Volunteer Awards were presented to 23 volunteers, recognising a combined total of 500 years of service teaching swimming, water rescue and survival skills in communities nationwide.

Community and Social Responsibility Awards

In recognition of the support given to Water Safety Ireland's community work, charitable activities and commitment to drowning prevention initiatives and the reduction of aquatic related injuries.

Cara's Transition Year class participated in the Young Social Innovators of Ireland for which they created an awareness campaign about the importance of being water safety aware. They organised a number of fundraisers and raised €1263.00 for Water Safety Ireland drowning prevention initiatives. We are delighted to recognise their efforts to help others

Danger Of Using Inflatable Toys, a video campaign by Cork Co Co and partners – Caroline Casey, Cork Co Co

Cork County Council in conjunction with Water Safety Ireland, the RNLI, the Irish Coast Guard, and several other Local Authorities produced two short films on the dangers of using inflatable toys in open water. One of the educational videos is aimed at primary school children and the other targets adult audiences. This Award goes to Smart Dublin for coordinating three companies to pilot a low-cost alert system that reports when ring buoys are used for a rescue, go missing or are tampered with. Vanessa is a visual artist and long distance swimmer who has organised water related art projects around the world, in this case a Cork Endurance Swim that had swimmers in the pool for thirty hours. Proceeds of the event went to Water Safety Ireland’s local initiatives in Cork and local clubs and swim groups supported a project that inspires and celebrates swimming and swimming communities. Thank you Vanessa for using your love of swimming to help others connect with our aquatic environments.

Wix and Wax – Danielle Kenneally and Chantell Keane

Danielle’s brother Jack was just 15 when he and his friend Shay Moloney lost their lives after getting into difficulty swimming in a disused quarry. She and Chantell decided to raise funds for a water safety awareness initiative. They co-founded a home fragrance business “Wix and Wax” and donated a month’s profit from the sale of a specially created ‘Daisy snap-bar’ to WSI. The daisy has a strong significance to the Kenneally family as Jack kept a daisy on the back of his phone, and that’s something that Danielle holds dear. A water safety tips leaflet was included with every fragrance bar sold. Thank you Danielle and Chantell for helping to raise awareness and protect others from drowning.

Galway Bay User’s Group – Kevin Gately & Michael Swan

Kevin and Michael were instrumental in setting up “The Galway Bay Users Group”, established as a partnership, linking statutory, commercial, educational, sporting and voluntary agencies involved in marine activity in the greater Galway Bay Area. The voluntary group facilitates the sharing of expertise, technological and scientific advancements, research and local knowledge in a collaborative manner to promote and advance efforts, particularly in marine safety and Search and Rescue/recovery operations for the benefit of the wider communities that use Galway Bay. Thanks to Kevin and Michael for helping to bring everyone together to improve safety for all.

Leon Quinlan Perpetual Award

Clonmoney National School – Clíodhna Mc Cannon

The Leon Quinlan Perpetual Award is presented to a primary school that has been particularly attentive to the need for pupils to learn water safety skills. When young Leon Quinlan drowned in 2004, his mother Lynn contacted Water Safety Ireland about running an event to raise awareness about water safety. Funding from that event enabled WSI to recruit an Education Development Officer to visit primary schools and teach water safety awareness to pupils. Lynn's support has enabled thousands of children to learn how to stay safe near water. This year's recipient is Clonmoney National School in Co Clare to whom we are most grateful for delivering Water Safety Ireland's Primary Aquatics Water Safety Programme to their pupils. Coordinated by their teacher Ms Mc Cannon, the children learned about local hazards in the home, on the farm and other aquatic environments nearby. We are very grateful to Clonmoney National School and congratulate them for ensuring that the children in their care have the knowledge and skills necessary to stay safe from drowning.

Avery Greene Memorial Award

Rosnaree Kids Club.

Avery Greene was just three-years-old when, in 2019, he tragically drowned while on holiday in Spain . Avery's mother Amanda became an enthusiastic promoter of an education resource called Hold Hands that was developed by Water Safety Ireland and distributed to more than 4,000 Early Learning Centres nationwide. It contains lots of games and fun activities designed to encourage this young age group to talk about water safety and it has been embraced by Educators around the country, including today's recipient of the very first Award - "Rosnaree Kids Club", a preschool and after school service for young children. The club has encouraged the children to learn lots about water safety. For all children, it has been a disruptive time with swimming pools closed and without swimming lessons but thanks to places like Rosnaree Kids Club, very young children will have a sense of how to stay safe from drowning and for this we are very grateful.



Sports Persons of the Year Award

This year, Water Safety Ireland is recognising those volunteers who have made significant contributions to lifesaving sport in Ireland. It takes an army of enthusiastic volunteers to coach, chaperone, organise, and host competitions and training nationwide. Thanks to their selfless dedication, Lifesaving Sport participation levels is at an all-time high and their dedication is also reflected in the number of title-winning performances at national and international competitions.

This year, we recognise the efforts of two people who to this day remain pillars of lifesaving sport volunteerism. Together, they were founding members of what is now called the Sports Commission which has developed the traditional lifesaving competitions in line with international best practice. These two individuals have been the back bone of many Irish teams that have now gone on to become an established force to be reckoned with at international lifesaving competitions.

Brendan McGrath, Co Clare

Brendan Mc Grath is a lifelong member of Water Safety Ireland, having started lifesaving as a trainee instructor over 50 years ago, teaching lifesaving and swimming in summer and winter. He is currently the head coach of the National Lifesaving team and has coached lifesaving sport to all national and international levels.

Since starting as National Coach in 2004, Brendan has coached Irish competitors to secure many medals at European and World level. Brendan has played a key role in the development of the National Squad structures that have enabled Irish teams to achieve these accolades.

In addition to coaching, Brendan has written Water Safety Ireland's Lifesaving Sport Coaching Manuals, a framework that will facilitate the training and development of coaches all over Ireland.

Brendan also played a key role in the building of the Whitestrand Lifesaving Training Centre, which opened in 2015. He has also taken the lead in an ongoing project to build a similar training and rescue centre in Lahinch which is nearing completion. Brendan is very involved at a community level, dedicated to ensuring that local kids get the opportunity to train and use these facilities.

Brendan has consistently dedicated his time and energy to the ethos of Water Safety Ireland, sharing a lifetime of expertise and learning, for which athletes are extremely fortunate and grateful. A deserving recipient of Sports Person of The Year 2021.

Seamus O'Neill, Co Donegal

Seamus O Neill is the current Vice-Chairman of Water Safety Ireland, a Council member and volunteer with his local Water Safety Area Committee in Donegal.

In addition to his extensive contributions at an organisational level, Seamus is committed to the development of Lifesaving sport in Ireland. He played a major role in the establishment of the original Sports Commission and is a previous chair of the that Commission. His commitment to developing the sport is not limited to local or national level, having been involved in Irish

contingents traveling the world to learn about the sport and bring back what they learnt to pass on to competitors and volunteers. He was part of the first Irish group to become international referees and has served as a member on the European Sports Commission, thus ensuring Ireland's involvement in the development of the sport internationally.

No matter how bad the weather, Seamus can be found on a beach in a red referee jacket, running the beach flag arena or on the water's edge refereeing the different events. He is a familiar face on the beach at all Irish lifesaving competitions and the events would not have been so successful over the years had Seamus not organised the courses on which the competitions ran. He also organises a rescue boat to travel to events nationwide. Seamus has been a driving force in Donegal Water Safety Area Committee upon which he has served in many different roles. Today he still plays a very active role in training and coaching Donegal lifesaving teams as well as being involved in the development of the new Donegal training centre in Creevy.

Seamus is also the "man in the van", stretching back to when he brought some of the first Irish teams to international competitions in the 1990's and organised for some of the first competition rescue boards and skis to come back to Ireland. He also ensures that the national team equipment gets to European Competitions safely. Seamus recognised that having this personal equipment at competitions makes the world of difference for athletes when it comes to competing with the best in the world. Without this gear Irish teams would not be as competitive on the international stage. Seamus is a vital member of the traveling contingent, always offering to help transport people and equipment. On behalf of Water Safety Ireland and all of the competitors, we are proud of the commitment to lifesaving sport shown by Seamus, a deserving recipient of Sports Person of the Year.

Volunteer of the Year Award

Andrew Lally – Volunteer of the Year

Since he was a child, Andrew Lally has had a love for all things aquatic, honing his skills by taking Water Safety Ireland classes in his early teens at Leisureland swimming pool in Galway. He developed a love of lifesaving and throughout his university studies, lifeguarded in Galway city and county. Andrew developed these skills further to become a very active WSI Instructor, assisting with summer water safety weeks, and training hundreds of lifeguards and lifesavers.

His busy work life as a dentist has never curtailed his enthusiastic involvement with the Galway WSI Committee which he currently chairs. Andrew also continues to train both pool and beach lifeguards and his dedication is further reflected in the fact that he continues to teach water safety every Sunday morning at his local pool.

In addition to his involvement in training lifeguards and teaching water safety, Andrew also gives up a huge amount of time to lifesaving sport. He is an active international referee and has travelled all over the world, voluntarily giving up personal holidays to support and manage national teams and at the same time carry out his duties as a referee. Andrew is a familiar face to all national competitors from nippers to masters and is a stalworth at pool and beach competitions. As a referee and manager to national teams, Andrew has travelled in a voluntarily capacity to many international events, utilising his personal holiday time to do so, and solving a range of challenging scenarios to ensure everything is run smoothly and safely.

The SEIKO “Just In Time” Award

Presented to those who came to the assistance of person(s) in difficulty in water and in danger of drowning. Without their quick thinking, the outcomes could have been very different.

Ruairi Brennan – Laois: In July this year, while swimming at the River Nore in County Laois, Ruairi noticed a woman who was unable to swim enter the water. He tried to assist her and quickly realised that he needed to take her in tow. Ruairi calmed the woman down and managed to take her in a carry to the bank. Well done Ruairi.

Tina Kavanagh – Kilkenny: In the summer of 1985, Tina was a teenager swimming at Graignamanagh, County Kilkenny when she noticed a young boy in distress in the water. He had gotten into difficulty after receiving an accidental knock to his head. He subsequently swallowed water and began to panic. Tina swam to the boy and tilted his head back, all the while reassuring him and eventually took him to safety. Well done Tina for your quick thinking.

Gary Heelan – Cork: On the 6th of November last year, Gary was out for a walk on the banks of

Blackwater, Mallow, Co Cork. He noticed a young woman in the river on the opposite side of the bank, who was holding on to a tree and in difficulty. Gary immediately ran across the bridge, down the opposite bank of the river and contacted the emergency services. He made his way to the casualty and tried to assist her from the bank. Gary entered the water and against a strong flow managed to help her to safety. A very well deserving award indeed. Congratulations Gary.

Patrick Mungovan – Clare: In July this year, a young girl fell into the water at Quilty pier, County Clare. Patrick became alerted to the situation and without hesitation jumped into the water, before bringing her back to safety. Patrick was aware of the area and was able to identify a slipway to bring the young girl back to safety. Congratulations Patrick.

Zoe Lally – Sligo: In March this year, a group of youths were playing at Easkey pier in County Sligo and watching the waves wash over the top of the pier. A large wave suddenly broke over the breakwater and down onto the boys, washing them off the pier and into the sea. Zoe, an experienced surfer, ran onto the pier and managed to pull two of the teenagers to safety with the aid of ringbuoys. She then swam out to the third boy and managed to bring him to safety further along the coast. A wonderful rescue, well done Zoe.

Daragh Flynn – Wicklow: In July this year, Daragh was walking across a bridge at Clara Funpark, County Wicklow when he noticed a small child in the water. He immediately jumped into the water and picked her up into his arms. After saving her from the water he helped to warm her up and was assisted by an off-duty paramedic. They took her to a first aid room where they kept her warm until emergency services arrived. Another wonderful rescue, Well done Daragh.

Ger Daly – Galway: In September 2019, Ger was swimming with a group at Salthill, County Galway when one of the group got into difficulty. He soon realised the man was unwell, at which point Ger turned him onto his back and towed him safely to shore where he regained consciousness. Ger waited with him until emergency services arrived and the man made a full recovery. A very well done Ger.

Philip Owens – Louth: In July this year, Philip noticed the coastguard passing by enroute to a person in difficulty in the water at Whitestown, County Louth. He immediately located a kayak and paddled out to the person in difficulty. Philip gripped onto the man's lifejacket and stayed in position until a rescue boat arrived at the scene. He then assisted the man onto the rescue boat. Well done Philip.

Michael Carrig (Just In Time Award) and Marguerite Carrig (Rescue Appreciation Award) – Clare: In July of 2005, Michael and Marguerite were boating when they observed changing weather conditions as another boating family were turning for home on the Shannon Estuary in County Clare. They followed the small boat as they realised it was in jeopardy of being overturned. They took the woman and children on board their larger boat and safely escorted the man on the small boat to his destination. Michael receives a Seiko Just In Time award and Marguerite receives a Rescue Appreciation award. Well done to you both.

Nikki Wan – Dublin: In October this year, Nikki was walking her dogs along the Grand Canal, at Harold's Cross bridge when she noticed a pair of men's trainers submerged under the water. She grabbed the man's hood and managed to bring him to safety to the riverbank. She then checked his pulse, placed him into the recovery position and remained with him until emergency services arrived. Nikkola would like to thank Justin from Dolphin's Barn Fire Station for nominating her and everyone at Water Safety Ireland for her award. Nikkola would also like to dedicate this award to her mum, and her stepdad Tony who is currently in hospital.

Tommy Moyna – Monaghan: On July 25th this year, Tommy was working on a farm when he heard shouting from a man and woman in difficulty in an adjoining lake. He immediately dived under the water and pulled the submerged woman above water. The man also held onto Tommy who successfully managed to tow the couple to safety. A sincere thank you Tommy.



Mark Kavanagh – Wexford: In July this year, Mark became aware of a woman in distress in the water at a bridge in Wexford town. The RNLi were on their way to the scene when they witnessed Mark lifting the woman out of the water and into his boat. He brought her to the Wexford quay front where emergency services were waiting. Well done Mark for your quick lifesaving action.

Joseph McNulty, Kristin McNulty and Sean McNulty – Donegal: In September this year, McNulty family were walking on Bundoran Beach, County Donegal when they noticed three girls trapped on a sandbank by surrounding water. Two of the girls were trying to swim to safety and the third girl was now stranded up to chest level in the water. Kristin grabbed a ringbuoy, while both Joseph and Sean entered the water up to their waist. The ringbuoy was used to pull two of the girls to safety. As Joseph & Kristin edged closer to the third girl, Sean also entered the water with the ringbuoy. He managed to reach her and pull her to safety in a cross-chest hold. Well done Joseph, Kristin and Sean on a remarkable rescue.

The Rescue Appreciation Awards, for coming to assistance in a rescue.

Declan Reid from County Kildare, posthumously

In February 2021 Declan was on the bank of the River Barrow, with a rope tied to his son's kayak. Suddenly the kayak overturned, at which point Declan jumped in to rescue his son Arron. Declan managed to hold Arron up in the water until other family members and members of the public were able to bring Arron to shore. Tragically, Declan went below the water and was lost to the river. A truly selfless act.

Stephen Clarke from County Dublin, posthumously.

In November 2012, Stephen was working at a hotel along the River Liffey when he heard cries for help coming from the boardwalk. A woman was in difficulty and Stephen immediately entered the water. He managed to reach the woman and brought her to the other side of the river, where another young man arrived to aid the rescue. They eventually made it to a ladder, and all were successfully pulled out of the water to safety. A situation that could have had a tragic outcome if not for Stephen's efforts. Sadly, Stephen has since passed away due to an unrelated illness, but we are thankful and recognise his efforts to save a life.

Media Appreciation Awards

Presented in appreciation for covering drowning prevention and water safety issues throughout the year.

Local Radio Station Award: Midlands 103FM (Offaly)

Midlands 103FM is a local independent radio station broadcasting from Tullamore, Co Offaly to counties Laois, Offaly and Westmeath. Thanks to their coverage of water safety issues, listeners are more aware of the dangers at aquatic environments, and for this we are very grateful.

National Radio Broadcaster: RTÉ Documentary On One – Sarah Blake and Lorna Siggins, Producers.

Radio Telefís Éireann began broadcasting in 1926, making it one of the oldest continuously operating public service broadcaster in the world. Their Doc on One series brings you multi award-winning documentaries that tell real life stories. In this case, Sarah Blake and Lorna Siggins, producers created the Documentary on One production "Miracle in Galway Bay", one year on from the miraculous rescue of two young women stranded on paddle boards in Galway Bay. We are grateful to RTÉ for liaising with Water Safety Ireland on this and other water safety issues to deliver important messages to the public and for helping us to raise awareness and

to change attitudes and behaviours at our aquatic environments.

National TV Broadcaster: RTÉ News – Sharon Tobin, Reporter

Throughout the summer, thousands of people were attracted to Ireland's beaches and inland waterways nationwide. The waterways provided some relief from the Covid-19 pandemic and the public were able to enjoy these waterways thanks to the presence of trained Lifeguards. The importance of swimming at Lifeguarded waterways was raised on a number of occasions by RTÉ Reporter Sharon Tobin, who took the opportunity to raise get some great footage of all those who train and work so hard to keep people safe while enjoying the water. We are grateful to Sharon Tobin and the RTÉ News team for helping us to promoting this lifesaving resource.

Provincial Press Award: The Clare Champion - Colin McGann, Editor

The Clare Champion is a weekly newspaper that was first published in 1903. A strong voice for the local community, the newspaper has promoted many of Water Safety Ireland's messages to readers including the lifesaving classes conducted by our volunteers at the Rescue and Training Centre in Lahinch. They also provided particularly supportive coverage about lifesaving following the tragic loss of local Lifeguard and Surf Life Saving team member, Fionn O'Brien, following his accidental death in a surfing incident this past summer. We congratulate the Champion and thank them sincerely for helping to highlight water safety awareness.

National Press Award: The Irish Times – Jennifer O'Connell, Journalist

The Irish Times is a daily broadsheet newspaper and online digital publication that first printed in 1859. Their printed and digital editions have covered many topical water safety issues throughout the year. An example is an article by Jennifer O'Connell in which she described how experienced swimmer Jack Eoin Rua O'Neill quickly got into trouble in swells that he compared to being tumbled around in a washing machine. On the day of publication, seven people had drowned in seven days. We are truly grateful for this support as it helps to encourage readers to talk about water safety with friends and family.

Media Appreciation Award – online broadcasting: Her.ie - Kat O'Connor, Journalist

Her.ie is a lifestyle website that attracts an audience of 1.4 million people each month and has a following of 684,000 across their social channels. It provides a platform for information that engages readers through the lens of real women's lives. Journalist Kat O'Connor illuminated on the tragedy of child drownings, in this case through the eyes of Amanda Cambridge whose loss of her son Avery prompted Amanda to engage with journalists like Kat to water safety education for young children. We are grateful to her.ie for raising awareness with their readers.

Analysis of Drownings 2021

Water Safety Ireland - targeting at-risk groups with drowning prevention initiatives.

The total number of drownings in Ireland in 2021 was 80, four more than in 2020 when 76 drowned. The average number of drownings each year over the past ten years is 110. Each figure in the following graphical analysis, be it accidental, suicide or of undetermined cause, reflects a preventable tragedy that affects so many lives. Water Safety Ireland continues to target at-risk groups with initiatives to highlight best practices so that drownings are reduced.

A synopsis of some general contributory factors over the years:

1. Poor or inadequate equipment (e.g. boats or lifejackets);
2. Not wearing a correctly fitting lifejacket;
3. Alcohol consumption;
4. Falling unexpectedly into water;
5. Improper use of boats and equipment;
6. Overestimation of skills; underestimation of ability;
7. Lack of local knowledge when travelling in Ireland and abroad;
8. Not being able to swim or not having lifesaving and water survival skills;
9. Easy unauthorized access to waterways;
10. Cold water shock and hypothermia;
11. Current (including rip currents, river currents, and tidal currents);
12. Offshore winds (including flotation devices);
13. Pre-existing diseases;
14. Underwater entanglement;
15. Bottom surface gradient and stability;
16. Waves (coastal, boat);
17. Water transparency;
18. Impeded visibility (including coastal configuration, structures and overcrowding);
19. Lack of parental supervision (infants and children);
20. Change in weather conditions;
21. Excessive "horseplay" or over exuberant behaviour;
22. Swimming outside the depth of the user.

A synopsis of some general preventive and management actions:

1. Public education by Water Safety Ireland regarding hazards and safe behaviours;
2. Teaching children to stay away from water when unsupervised through the WSI PAWS (Primary Aquatics Water Safety) programme;
3. Continual adult supervision of children;
4. WSI media campaigns that drowning can happen quickly and quietly;
5. Promote in WSI press announcements, the restriction of alcohol provision before or during aquatic activities;
6. Provision by Water Safety Ireland of properly trained and equipped lifeguards;
7. Provision of rescue services;
8. Water Safety Ireland Risk Assessments that include assessments of local hazard warning notices, access to emergency response and availability of resuscitation skills/facilities and other factors;
9. Development by Water Safety Ireland of rescue and resuscitation skills among general public and user groups;





10. Coordination by Water Safety Ireland with user group associations concerning hazard awareness and safe behaviours;


2021 Drownings By Province
